The railway sector is living important moments: the European Commission has just released the Recast of the First Railway Package, the first decisions of the European Court of Justice concerning various infringements are about to be released, and we are awaiting the Fourth Railway Package.

In this light, the various stakeholders of the European railway sector are eager to know how liberalization will evolve. Especially, they want to know which form competition will take: will competition be about access as was the original idea of the European Commission or will it rather evolve into tendering of various bits and pieces of the railway system. Needless to say that the evolving market structure will in turn significantly determine how regulation will look like in the future.

The Forum will give the opportunity to executive managers representing the relevant stakeholders to address this issue by discussing, inter alia, the following questions:

- What will competition look like in the short, medium and long run?
- Will there be competition at all?
- If desirable, how can and will it be promoted?
- How can and will it be enforced?
- And what role will regulators play in the short, medium and long run in promoting and enforcing such competition?

We are certain that these questions, along with the current evolution of the European railway sector, will trigger interesting discussions and look forward to seeing you in Florence.
