

Each interface matters for performance



### Which aspects, which measures?

#### Depends on:

#### Who is asking and why?

Company management -	operational and financial performance
Customers -	price and availability of services, reliability and punctuality
Public authorities -	service quality, spending, state of networks
Regulators -	accessibility, safety, overall performance
EU institutions -	alignment with the EU transport policy goals, interoperability, market access, use of EU funds



## Performance in EU <u>technical</u> regulation

Technical subsystems

### Interoperability - Directive 2008/57/EC

• ERA monitors the performance in terms of interoperability standards

### Safety - Directive 2008/57/EC

• Common Safety Indicators are collected to facilitate the achievement of Common Safety Targets

#### TEN-T Guidelines - Regulation (EU) No 1315/213

Core Network Corridors – compliance with infrastructure standards



### Performance in EU <u>market</u> regulation

Rail companies (IMs, RUs, service operators) nationally and cross-borders

#### Single European railway area - Directive 2012/34/EU

• Performance schemes encouraging RUs and IMs to minimise disruption and improve the performance (Article 35, Annex VI)

#### Single European railway area - 4th Package amendment

• IMs shall cooperate to monitor and benchmark performance and to contribute to rail market monitoring

#### **TEN-T Guidelines** - Regulation (EU) No 1315/213

• Core Network Corridors - monitor network development and activity in multimodal corridors.



## Performance in EU <u>market</u> regulation

Rail companies and their (end)customers

Rail passenger rights - Regulation (EC) No 371/2007

RUs shall define and implement a quality management standards, covering punctuality, cancellations, cleanliness, customer satisfaction, complaint handling, assistance to PRM *(Article 28, Annex III)* 

#### **Rail Freight** - Regulation EU 913/2010

• Management boards shall monitor the performance of rail freight services and publish the results


#### Single European railway area - Directive 2012/34/EU

 Contractual agreements between competent authorities and IMs for infrastructure financing should include user oriented performance indicators (Article 30, Annex V)

#### **PSO** – 4<sup>th</sup> Package amendment to Regulation No 1370/2007


• In case of direct award, competent authorities shall include in **public service contract performance requirements**, including punctuality of services, frequency of train operations, quality of rolling stock and transport capacity for passengers (*Article 5*)










