POLICY EVENTS

The core activity of FSR Transport is the organisation of policy events, where representatives of the European Commission, regulatory authorities, transport operators, other relevant stakeholders, as well as academics in the field, meet to discuss and shape regulatory policy in the European transport sector. Since 2010 more than 40 events have taken place.

Most recently the following topics were discussed:

- Aviation: EU regulation of airport charges, Single European Sky: the way forward
- Railways: Green Finance and Sustainability – Which Role for Railways?
- Clean Mobility: Electric Vehicle Charging
- Road Transport - Road Safety

The *European Transport Regulation Observer* is published after each workshop and is part of the Robert Schuman Center Policy Brief Series. It is an open source publication highlighting the main outcomes of the discussions and featuring several comments by academics as well as a suggested reading section.

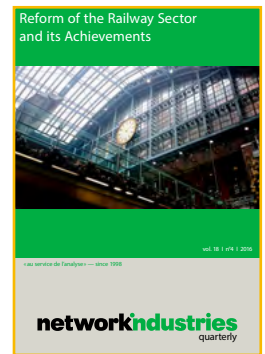

RESEARCH PROJECTS AND PUBLICATIONS

In cooperation with the École Polytechnique Fédérale de Lausanne (EPFL) and Istanbul Technical University, FSR Transport publishes the 'Network Industries Quarterly' (NIQ). The NIQ aims to cover research findings regarding the most compelling challenges deriving from liberalisation that affected network industries in the recent past, to monitor emerging trends, and to analyse the strategic implications of these changes in terms of regulation, risk management, governance and innovation in all, but also across, the different regulated sectors. FSR Transport also collaborates with the Innovative Governance of Large Urban Systems (IGLUS) Program to publish the IGLUS Quarterly. This publication aims to facilitate knowledge and experience sharing among scholars and practitioners who are interested in the improvement of urban systems performance in terms of service efficiency, sustainability and resilience.
