## FSR Global Capacity Building Model: IOC

#### Training Cycle 1

IOC blended training cycle consisted of three blocks specifically designed to meet the learning objectives of the Indian Ocean participants.

The first block was a threeday kick-off residential training which provided an introduction to power systems and grid regulation; renewable energy (RE) and how to introduce them into power systems; and how to optimise energy efficiency (EE).

The second block was an eight weeks online training focusing on the regulation of power sector which allowed the participants to concentrate on the main challenges within their local setting.

The third and final block of the programme was a two-day residential training which allowed the participants to present their country cases and discuss RE and EE energy regulation and energy policy issues pertinent to their nations.


