As of May 2026, 41 emissions trading systems are now in force worldwide, covering approximately 26% of global greenhouse gas emissions. Within this expanding landscape, the EU Emissions Trading System (ETS) is itself at a turning point: free allowances for industrial sectors are being phased out in parallel with CBAM entering its definitive stage, the Market Stability Reserve is being reformed to reduce price volatility, and a comprehensive review of the system is expected by July 2026. At the international level, the Article 6.4 mechanism has issued its first credits and the EU and UK have announced plans to link their ETSs. For professionals across industry, regulation, and finance, keeping pace with these rapidly evolving developments is no longer optional.

This two-day residential training course is designed for professionals seeking to delve into carbon markets and who wish to update their knowledge in the wake of the 2026 EU ETS review and further international developments. Set in Florence at the European University Institute-Florence School of Regulation from 8 to 9 February 2027, the course will bring together leading academics, EU policymakers, industry practitioners, and carbon market specialists to provide participants with a comprehensive and applied understanding of carbon pricing mechanisms and their global implications. By equipping participants with both conceptual grounding and practical tools, the course contributes directly to building the cross-sectoral community of practice that effective carbon market governance demands.
