Introduction

This course will provide an in-depth overview of the evolving regulatory framework supporting renewable energy investment in the EU, with a particular focus on Contracts for Difference (CfDs) and Power Purchase Agreements (PPAs).

The course will explore the main types and design features of CfDs, as well as the implications of different design choices for risk allocation, incentive alignment, implementation feasibility, and cross-border market integration. It will also cover the EU Electricity Market Design reforms and the European Commission's guidance on CfDs.

The section on PPAs will explore how to develop PPA markets that enable long-term hedging, covering topics such as standardisation, aggregation, platforms, and the removal of regulatory barriers, among others. It will also address PPA design to achieve specific policy objectives, including supporting the development of clean technologies.

The course will conclude with collaborative workshops aimed at strengthening peer-to-peer learning and encouraging exchanges between participants, instructors, and invited national experts.

For this training, there will be two cohorts of participants. While both cohorts will complete the identical curriculum across the three days, the sequence of modules will be staggered by group.
