Our events bring together the world of academia and practice to offer a vast range of opportunities for open discussion and practice sharing.



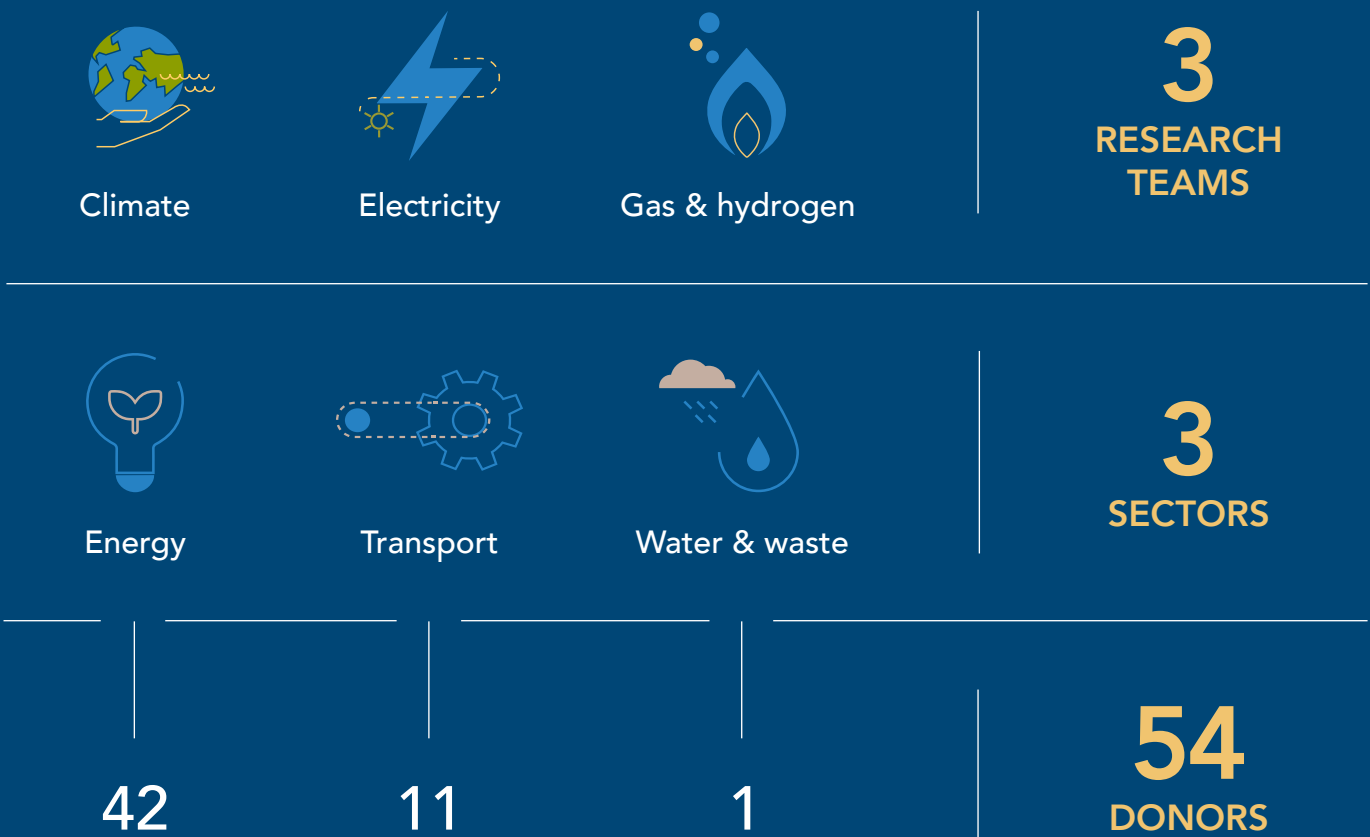

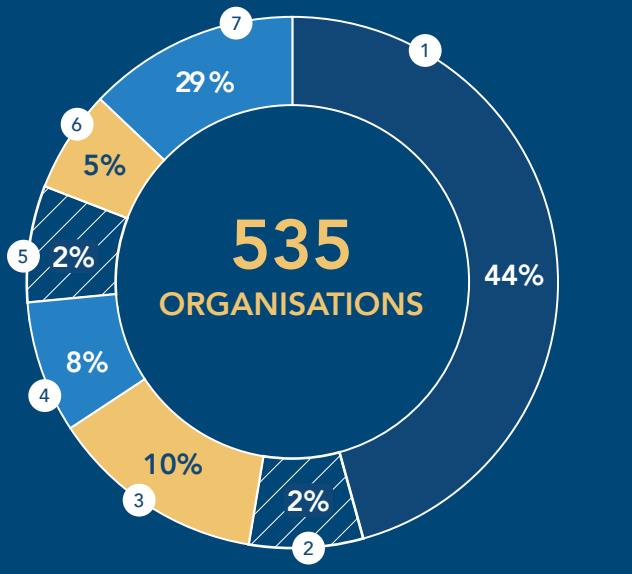

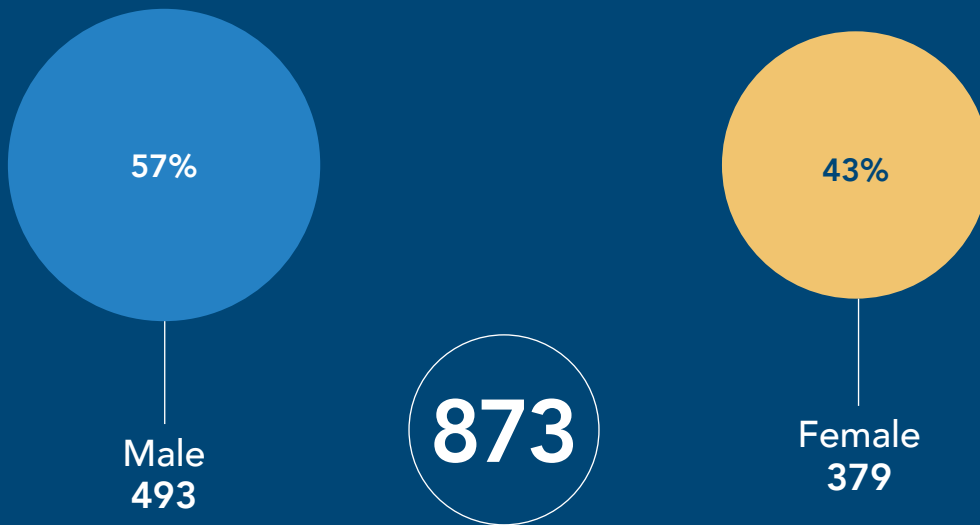


PARTICIPANTS' CURRENT EMPLOYMENT

At the Florence School of Regulation, we've spent two decades combining academic excellence with a positive impact on policy and regulation.

Starting from energy in 2004, we broadened to transport and digital in 2010, climate in 2012, and water and waste in 2014.

In 2024, we celebrated our 20-year anniversary and, reflecting on the many important milestones in our history, we realised that we didn't just grow in what we studied; we also grew in how we reached and engaged with people.

We have a workshop series and a training that runs since the beginning of our school. In 2008, we increased our research capacity. In 2014, we launched our first online training. In 2017, we initiated our gender mainstreaming initiative - Lights on Women. Our Scholarships programme followed in 2021, and in 2023, we welcomed our alumni back home with our first-ever Alumni Day in Florence.

What began as a European journey has now reached global horizons. The colleagues of the African School of Regulation moved to Accra in Ghana after



completing a two-year incubation period in Florence. They successfully developed their own activities focused on improving energy policy and regulation in Africa.

2024 was also the year of the EU elections. We contributed with two policy briefs with ideas for the next European Commission, one focusing on energy policy, the other on transport policy. Ursula von der Leyen has been reelected as European Commission President. Energy, climate, water, waste, and transport feature prominently in her political guidelines. The implementation of the EU Green Deal will be continued with complementary initiatives on issues such as security, competitiveness and industry. We continue to engage with this process.

The numbers presented in this annual report paint part of our picture: we organized 27 executive education courses with 1100 participants; we produced 32 publications, 100 blog posts, podcasts and videos generating 500k engagements on our website. We also welcomed 4500 attendees in 80 events online and in Florence. All of this led to an increase of our newsletter subscriptions to 25k.

But it's not just numbers. It's the stories behind them. Like the young professional at a Women in Energy breakfast who said our Lights on Women database helped her land her first conference panel. Small actions, big ripples.

At our 20th anniversary, Pippo Ranci, our first director, reflected: "We have done what we have been able to do, which is so little, so small, and yet something has come out, and it is fantastic. Beyond imagination. We did not dream of a day like this; it is beyond our dreams."

Those words stay with us as we look ahead. There's more to learn, more to share, and more to change and improve.

Executive education

Our courses are designed and continuously updated to meet the educational needs of energy professionals at all levels. The courses are developed with the support of an outstanding international training faculty, which includes professors from top universities as well as high-level experts in energy regulation, policy-making, and industry.

We offer different types of training courses: Online (Class and Community), Residential, Blended (online & residential) and Tailor-made training (TMT) courses at all levels of knowledge. There are three levels:

Level 1 – Highlights

it gives participants an introduction to the topic with the newest updates from the field.

Level 2 – Fundamentals

it gives a comprehensive overview of the topic. Participants will dive into the significant elements of the field, thoroughly studying the concepts and refining their accrued knowledge together with peers and instructors.

Level 3 – Specialised Training

it takes an in-depth look at a specific topic of the field. These are advanced courses that require a solid background and provide you with a deeper understanding of the subject. Participants are encouraged to take an active role in the course activities as well as apply the specialised information to practical cases.

6th Lights on Women Scholarships

The annual Lights on Women scholarships are dedicated to supporting ambitious early- and mid-career women in advancing their professional journeys by enhancing their skills and expertise. These scholarships offer free access to FSR online community courses of their choice.

In its 6th edition, the Lights on Women Scholarship programme awarded 10 scholarships to women making significant contributions to innovative energy solutions, research, and initiatives that promote a sustainable, diverse, resilient, and equitable energy transition. This year's recipients hail from eight countries across three continents and possess diverse interests, including climate security, energy market modeling, SDG7, clean technologies, and environmental development. Their professional backgrounds are equally varied, spanning roles as law firm associates, engineers, academics, and entrepreneurs.

7th Ana Aguado Scholarship

The Ana Aguado Scholarship is a tribute to the late Ana Aguado, who was the Secretary-General at EDSO. The scholarship is organised in collaboration with the European Distribution System Operators' Association (E.DSO), the European Network of Transmission System Operators for Electricity (ENTSO-E), the Union of the Electricity Industry – Eurelectric. Ana was a passionate and dedicated advocate, always at the forefront of major challenges in the energy sector. Throughout her career, she showed great attentiveness to the needs of students, firmly believing in the transformative power of education for future generations.

To honour her commitment, this joint initiative annually allocates two scholarships for the *Summer School on Regulation of Energy Utilities* and four additional scholarships for FSR online community training courses. Scholarships were awarded to students and young professionals who provided the best essay on the following topic: *“In June 2023, the European Court of Auditors stated that EU countries are vague in their plans to meet climate targets and, due to a relevant financing gap, risk not achieving the EU’s objective of reducing emissions 55% below 1990 levels by 2030. Do you think missing the 2030 targets can irremediably hamper the chances of the EU to achieve Net Zero by 2050? If so, why? Or do you think there are some additional actions that can be taken to revert the trend? If so, please briefly describe one or two of them”*.

3rd FSR Annual Scholarship

The FSR Annual Scholarships were established to support passionate individuals seeking to expand their expertise in energy regulation by offering free access to FSR training courses. These scholarships aim to train and develop

the next generation of students and early-career professionals in the energy sector across a broad spectrum of topics. In line with this mission, FSR awarded 22 scholarships for 12 community and class training courses to dedicated candidates committed to learning, networking, and contributing to a global energy community.

Our partner, Landwärme, generously sponsored two scholarships for the *Clean Molecules for the Energy Transition course*.
