Introduction

Space technologies are now woven into every sector at an unprecedented pace, creating impacts that ripple across infrastructure, governance, and commerce. The economic impact? To delve deeper into these impacts and interconnections, the Florence School of Regulation, in collaboration with the European Space Policy Institute (ESPI), co-organised a Summer School on Space Policy, which aims to:

- Deliver in-depth, high-impact training on space policy and strategy
- Spark interest in the space sector among both emerging and established professionals
- Highlight the relevance of space in addressing broader societal challenges
- Create a networking bridge between professionals from the space and non-space sectors

Convened under the theme “Space Beyond Space: The Impact of Space Integration across Sectors”, this year’s programme will focus on the systemic integration of space across different segments of the economy and public policy, with particular emphasis on three key domains: space for energy and infrastructure, space for digital transformation and governmental services, and space for natural resource management. Participants will also be invited to draw connections with their own professional backgrounds and explore how space-based capabilities can support innovation and policy solutions across diverse sectors.
